Payment Terms

A nonrefundable deposit of \$250.00 is required to claim buying rights to a puppy (\$50 waiting list fee* plus \$200 at puppy selection time). This deposit is used towards the purchase price of the puppy.

Full payment of the price agreed at time of deposit is due within five days of chosen puppy turning nine weeks old. When chosen puppy is nine weeks old, five days is allotted to pay the remaining balance and pick up the puppy. *Payment must be verified on or before pickup date.*

Puppies are sold individually at a base price of _____

Additional fees or charges may be added to the base puppy price according to current market demand for certain coats, colors, sex, or size (e.g. Isabella and Tan male smooth hair).

Additional fee or charge for puppy selection _____

Payment methods include cash, check, or money order. Checks and money orders must be verified PRIOR to taking possession of the puppy. Buyer is responsible for any returned check fees.

**Waiting list position is guaranteed by date payment is received, and breeder has first rights to any or all puppies in a litter. Seller has right to refuse sale at any time prior to contract signing.*

Guarantees

Buyer

The buyer must have the puppy examined by a licensed veterinarian within 72 hours of taking possession of the puppy.

If the buyer can no longer provide the care and attention the puppy needs, or the puppy is confiscated by authorities, the puppy must be returned to the seller without compensation or refund. If ownership is transferred, new contact information must be provided to the breeder because most puppies will be microchipped before eight weeks and registered in a lost animal database.

The buyer guarantees that the puppy will not reside in or be consistently/significantly exposed to second-hand smoke or harmful bacteria. *Note: small dogs are typically not vaccinated against Leptospirosis which is a disease that both pets and people can get. Leptospirosis is caused by bacteria, not a virus. It can be transmitted through bodily fluids or through the consumption of infected food or water.*

Seller

At time of sale, each puppy is guaranteed to be in good health, vaccinated, and dewormed. If, during the veterinarian examination within the first 72 hours, the puppy is diagnosed with a life-threatening condition, a replacement puppy of equal value will be provided when it becomes available. This guarantee is null and void if ownership of puppy changes or if buyer chooses not to have puppy examined by a qualified veterinarian within the first 72 hours of ownership.

The health guarantee is limited to life-threatening conditions once the buyer takes ownership of the puppy. Common canine parasites such as fleas, ticks, worms, mites, giardia, coccidia, etc. are not covered under the health guarantee. Additionally, common hernias, adult size, conformation, fertility, dental problems that do not impact ability to consume food, or any other non-life-threatening conditions are not guaranteed.

Terms and Conditions

A separate contract is required for each puppy.

Puppies, by default, are not sold with American Kennel Club (AKC) registration. If requested, limited registration may be available at an additional cost based on waiting list preferences, but this is only necessary if the buyer chooses to participate in AKC events or programs. When puppies will be used for breeding purposes, the breeder may grant full AKC registration for an additional cost.

The buyer assumes full responsibility for the puppy's health, training, temperament, and appearance upon possession. Under no circumstances is the breeder held responsible for the puppy's health (other than previously stated) or behavior once the puppy leaves the breeder's property.
